

Photo Competition 'Life through a Lens' Terms & Conditions



Forest of Bowland National Landscape

Entrants must be 18 years or over.

1. Maximum of 3 photos per entry and they must be taken in the Forest of Bowland National Landscape. Follow this link to view a map of the [Forest of Bowland](#).
2. Photos can be entered in any of the categories but must not be duplicated across categories.
3. Only electronic, high-resolution photos will be accepted (maximum file size 50mb). If possible, 300 dpi and 8-bit for best printing quality.
4. **Photos must not be submitted to any other competitions or initiatives.**
5. Winning photographers will be awarded a maximum of one prize.
6. Photos do not have to be taken specifically for the competition, entrants can submit photos taken from past seasons and years in Bowland.
7. Name and contact information will be kept for the purpose of contacting you about using the photograph(s), and if we need to clarify anything with you. By entering your photograph(s) you agree to the Forest of Bowland National Landscape Team (hosted by Lancashire County Council) collecting, saving and processing your personal data for this purpose.
8. If you would like your name included alongside your image in Forest of Bowland publications and online, you need to give specific consent for this when you upload your photos.
9. It is your responsibility to remove the metadata embedded within the image if you do not wish to share this with us. We will store your photos in the same format that they are uploaded to the website, including any metadata embedded within the image.
10. All entries must be the original work of the entrant and must not infringe the rights of any other party. The entrants must be the sole owner of the copyright and any other intellectual property rights in all photographs entered. The entrant must have obtained permission to use or feature any people, content or other material, and must have the legal consent of the parents/guardians of any children under 18 who are featured. People should be made aware that the images may appear on websites and in printed and other media, including social media, and may be shared with other organisations. Further, entrants must not have breached any laws when taking their photographs.
11. Entrants will retain the copyright of the photographs that they submit to the Forest of Bowland National Landscape Team. By submitting your photographs all entrants grant the Forest of Bowland National Landscape Team the right to publish and exhibit their photographs on websites, social media, print, in press releases and other media related to the promotion of the Forest of Bowland National Landscape and to share them with other relevant organisations. No fees will be payable for any of the above uses. While we make every effort to credit photographers (if consented to do so), including in printed reproductions of their work, we cannot guarantee that every broadcast use of the photographs will include the photographers' names.
12. The Forest of Bowland National Landscape Team reserves the right to remove or refuse any entries from the competition for any reason.
13. Please do not submit a photo to the competition unless you are prepared to agree to these terms.
