**RABI are a fantastic Charity and can help you deal with your own personal circumstances by offering you tailored support in the form of bespoke grants, help and advice. Please contact them to discuss your personal situation and they will try and support you as best they can. They also offer -**

- In-person or online counselling and support, specifically aimed at farming people and without having to wait for NHS referrals.
- Training grants to help you up-skill, examples include - tree surgery, hedge-laying, butchery, livestock foot-trimming, pregnancy scanning, etc, along with computer skills such as website design and IT programming. RABI have also supported individuals to gain HGV licences and complete forklift truck operator courses.
- RABI can provide grants to support you during the cost of living crisis, or to help fund a temporary employee to cover you or your worker through times when you are unable to work (due to ill health/injury etc).
- Return to School grant of £250 for those whose main source of income comes from farming, to help with costs of school uniform etc. (payment is per household not per child, opens June – September.)
